CCE IS A STATEWIDE GENERAL REVENUE FUNDED PROGRAM THAT PROVIDES SUPPORTIVE SERVICES TO NON-MEDICAID FRAIL SENIORS. THIS COMMUNITY BASED PROGRAM IS PART OF A CONTINUUM OF CARE TO HELP FUNCTIONALLY IMPAIRED OLDER ADULTS LIVE IN THE LEAST RESTRICTIVE, YET MOST COST EFFECTIVE, ENVIRONMENT SUITABLE TO THEIR NEEDS.

HOME CARE FOR THE ELDERLY (HCE)

HCE IS THE STATEWIDE PROGRAM THAT SUPPORTS CAREGIVERS OF ADULTS 60 YEARS OLD AND OLDER IN FAMILY-TYPE LIVING ARRANGEMENTS WITHIN PRIVATE HOMES, AS AN ALTERNATIVE TO INSTITUTIONAL OR NURSING HOME CARE. A BASIC SUBSIDY OF \$160/MONTH IS PROVIDED FOR SUPPORT OF THE ELDER AND SPECIAL SUBSIDY MAY ALSO BE PROVIDED FOR SERVICES AND/OR SUPPLIES.

ALZHEIMER'S DISEASE INITIATIVE (ADI)

ADI IS A STATEWIDE PROGRAM PROVIDING A CONTINUUM OF SERVICES TO MEET THE CHANGING NEEDS OF NON-MEDICAID INDIVIDUALS WITH, AND FAMILIES AFFECTED BY ALZHEIMER'S DISEASE AND RELATED DISORDERS. THIS PROGRAM INCLUDES: MEDICAL SUPPLIES AND RESPITE FOR CAREGIVER RELIEF, MEMORY DISORDER CLINICS, MODEL ADULT DAY CARE PROGRAMS AND THE BRAIN BANK TO SUPPORT RESEARCH.

LOCAL SERVICE PROGRAMS (LSP)

LSP PROVIDES FUNDING TO EXPAND LONG-TERM CARE ALTERNATIVES THAT SUPPORT NON-MEDICAID ELDERS TO MAINTAIN A FAVORABLE QUALITY OF LIFE IN THEIR HOMES. LSP ALSO TARGETS UNMET, SPECIFIC COMMUNITY SERVICE NEEDS, SUCH AS CONGREGATE OR HOMEDELIVERED MEALS IN REGIONS WITH HIGH NUMBERS OF AT-RISK SENIORS.

FCOA 2025 LEGISLATIVE BUDGET PRIORITIES

THE FLORIDA COUNCIL ON AGING SUPPORTS THE GOVERNOR'S RECOMMENDED INCREASES TO SERVE FRAIL SENIORS AT RISK FOR NURSING HOME CARE WHO ARE ON THE PRIORITIZED, DEPARTMENT OF ELDER AFFAIRS WAITING LIST.

- \$8 MILLION INCREASE FOR COMMUNITY CARE FOR THE ELDERLY (CCE)
- \$6 MILLION INCREASE FOR ALZHEIMER'S RESPITE CARE (ADI)
- \$7 MILLION INCREASE FOR HOME CARE FOR THE ELDERLY (HCE)
- ADDRESS CURRENT WORKFORCE SHORTAGES ESPECIALLY IN THE CERTIFIED NURSING ASSISTANT AND HOMEHEALTH CARE FIELDS.
